At request of Charles Mitchel made a survey to establish the north east corner of Section 18, found the corner stone at northeast corner gone. Found old stone in place one half mile north, witness pine, ten inches in diameter east seventeen feet, chestnut oak six inches in diameter, south twenty five degrees west seventeen and one half feet.

Ran south distance as given by the recorded plat.

b Found old stone one quarter mile east, ran west distance as given by recorded plat.

Established the north east corner of Section 18, at the inter-section of the two lines run. Placed a stake at this point. Found the true distance from the half section stone on the north to this point to be thirty nine and fifty hundredths chains. Found the true distance from the quarter mile stone on the east to be twenty one and twenty five hundredths chains.

Then proceeded to survey the land purchased by Charles Mitchel ^{from} James K. Fox to establish the boundary of this tract of land. I found that the deed made by James K. Fox to Charles Mitchel made the starting point six rods west of the north east corner of Section 18 while the deed made later to Jacob Woltz made this same distance nine rods. I found that the distance as given by the deed made to Jacob Woltz corresponded with the fence on the ground. I also called L. C. Friend as a witness. After having sworn him I asked him if he had originally measured and marked off this piece of ground. His reply was "That at request of James K. Fox and Charles Mitchel he had marked off and surveyed this tract of land with a rod pole, and that he had ran nine rods west of the north east corner of Section 18 for a starting point.

I then ran south following the description as given in the deed made by James K. Fox to Charles Mitchel, a distance of nineteen and forty eight hundredths chains. At this point made a cross on the solid rock. I then ran west thirteen and forty six hundredths chains which is three rods short of Thomas Foxes corner as called for by the deed, but now owned by Charles Lunsford.

I then ran north three and twenty five hundredths chains to the creek. I found the chestnut tree as called for in the deed at the point as designated. I then followed the creek by the following lines:- North 46 east 1.25 chains; North 17° 38" East 8.55 chains; North 7° 28" East 2.58 chains; North 6° 10" East 1.62 chains; West 1 rod to the center of Cola bridge; I then ran north 32 ° East 2.73 chains along the center of the County Road to a point where the north line of Section No. 18 crosses the same, then ran east along the north line of Section 18, 8.14 chains to the beginning. I then questioned L. C. Friend as to whether these lines were the same that he had run off originally, his reply was "At the best of his knowledge these lines were the same that he had ran originally" in 1895. He further stated that the line as ran by him in 1895 was agreeable to both parties, namely James K. Fox and Charles Mitchel.

I took as my assistance in this work A. J. Nunemaker and Jacob Bigham as chain carriers and Fred Bigham as the marker, each and all of whom were sworn to perform the work in a fair and impartial manner.
