Thence N 10° 24' 58" E along a property line of the aforementioned Miller parcel and the Westerly property line of the aforementioned Vanover parcel a distance of 480.90 feet to a 5/8 inch iron pin found with a plastic identification cap inscribed "SEYMOUR & ASSOC.", said iron pin being a property corner of the Grantor, the Northwesterly property corner of the aforementioned Vanover parcel, a property corner of the aforementioned Miller parcel and the true **POINT OF BEGINNING** of the parcel herein described;
