



Being a part of what is known as the Hocking Canal, said tract being part of Fractional Lot 3 in Section 6 and part of Fractional Lot 3 in Section 5, T12N, R16W, Starr Township, Hocking County, State of Ohio and being more particularly described as follows:

N.M. COR. OF SEC. 5 T12N, R16W ESTABLISHED FROM U.S.R. 33 HIGHWAY PLAN




